#### **Building Fund for Grades 1 – 12**

In addition to tuition, Building Fund must be paid for each student.

The amount of building fund per student is determined by that student's grade level.

Students entering 1st grade through 6th grade: \$ 500.00
Students entering 7th grade through 12th grade.: \$ 400.00

**Building Fund to be paid:** 

Maximum of \$1,200 per family/household regardless of the number of children that family enrolls at Calhoun Academy

All new students entering Grades 1 - 12, including those who attended Kindergarten at Calhoun Academy, will pay a \$100 Application Fee. That \$100 is the first payment toward the Building Fund for a student.

In addition, students entering grades  $1^{st} - 10^{th}$  will pay an additional \$25 per quarter or \$100 per year until paid in full.

<u>Students entering 11<sup>th</sup> grade</u> will pay an additional \$37.50 per quarter or \$150 per school year for the next two years. In total, \$400 will be paid for that student by the end of their senior year at Calhoun Academy.

<u>Students entering 12<sup>th</sup> grade</u> will pay an additional \$75.00 per quarter or \$300 during their senior year. In total, \$400 will be paid for that student by the end of their senior year.
